### **New Research Project – The role of healthcare security professionals; their views, experiences and aspirations**

[Perpetuity Research](#) has been commissioned by the [National Association for Healthcare Security \(NAHS\)](#) to examine the key issues affecting the development of the healthcare security profession. The research will focus on 5 main themes:

1. key components of an effective governance framework
2. key gaps in current training provision
3. skillsets and training that are most valued
4. factors that enable the recruitment and retention of security personnel
5. key components of the 'value add' proposition

The findings will be shared publicly towards the end of 2025. NAHS is a free-to-join, not-for-profit association. Its aim is to further develop and professionalise the role of security in healthcare.

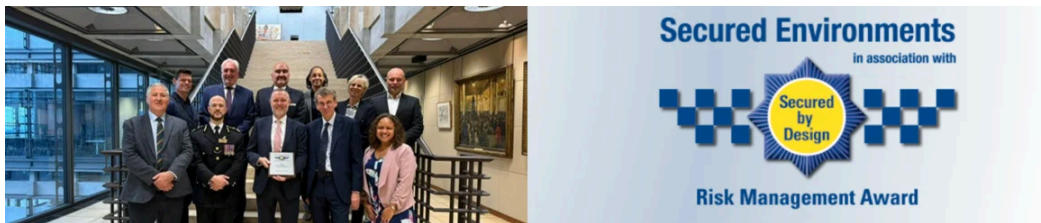


## Celebrating Excellence in Tackling Economic Crime

## SRI Report Published – *Optimising joint working between the police and private security*

The latest report from the Security Research Initiative (SRI) highlights the untapped potential for police and private security to work together. Despite distinct roles, both professions share common goals: reducing crime, protecting people and property, and gathering valuable intelligence. The report explores 12 distinct types of collaborative working, as well as the benefits and barriers to working together. Further, the report identifies 6 key opportunities to improve collaboration:

1. Understand what the private security sector does now
2. Stress the similarities between the police and private security
3. Be clear how private security benefits

4. Be clear how the police and public benefit
5. Understand that joint working does not have to be onerous
6. The need for strong leadership on both sides

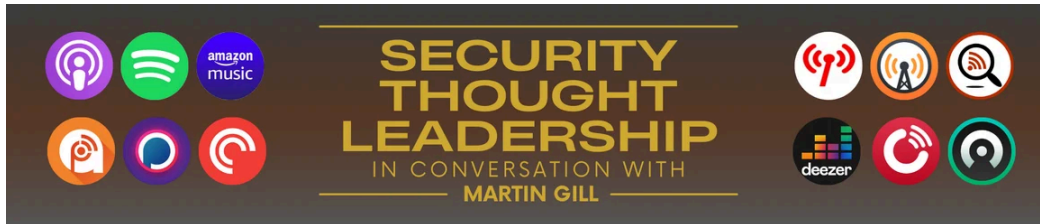
Professor Martin Gill who led the research noted:

*'Our research indicates that security professionals saw significant value in collaborative working with the police, particularly to better protect the public as well as organisations. There were many examples of joint initiatives which were considered beneficial. However, it was also apparent that much potential was untapped; that there is a general lack of joint working and that partnerships often do not achieve their full potential because of common barriers. The Policing Vision 2030 sets an objective to collaborate more to prevent crime, and this includes with businesses. What is needed now is strong leadership with a strategy to move collaboration forward.'*

Through these initiatives, Bill has continually inspired advancements in workplace safety practices, supporting the development of safer, more resilient workspaces worldwide.

- different forms of violence occurring across workplace settings
- the tailored responses they necessitate
- the limitations of having a Zero Tolerance policy
- the importance of implementing safe interventions

### Bill Tenney

Bill Tenney started work earlier this year as the new CEO of ASIS International. He brings a background as a security executive with extensive expertise in corporate security across business, government, and the military (he is a Navy veteran). His work has included securing data and enabling operations in over 40 countries at more than 10,000 global locations.

- leadership and key principles that govern his approach
- maximising the benefits of partnerships, and influencing stakeholder communities

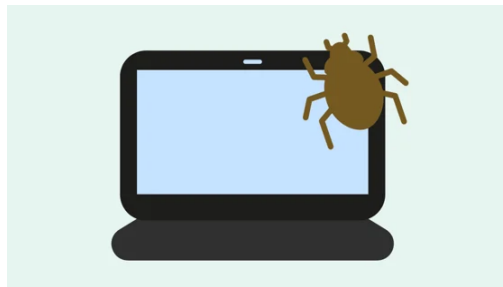

## Did you know? – Is that a bug in your computer?

The term "computer bug" originated in 1947 when engineers working on the Harvard Mark II computer discovered a real moth trapped inside the machine's relay, causing a malfunction. The team, including Grace Hopper, carefully removed the insect and taped it into their logbook, labelling the process as "debugging" the system. Although "bugs" in technology had been mentioned before, this incident gave the term its famous association with computer glitches. The original moth is still preserved in the Smithsonian Museum's collection as proof that bugs in computers were once literal.
