

Simon is a high-profile security entrepreneur. He started work in the area of alarm signalling and went on to develop one of the UK largest IOT critical connectivity providers. He has invested in other ventures including Skills for Security. Amongst his many other ventures he has started his own Foundation (The Banks Foundation (TBFL) which is a Founding supporter of the Security & Safety Entrepreneur Awards (SSEAs).

We created the first major reference point – a toolkit – for developing a security strategy at a time when few organisations had one, let alone an effective one. Our research into the characteristics of excellence in security led to the creation of the Outstanding Security Performance Awards (OSPAs), which now

operate globally and have inspired other ethically based award schemes, such as the Cyber OSPAs, TECAs, WVRAs, SSEAs, and FREAs.

# Did you know? - Received too many socks for Xmas?

While it might seem strange, there are reports indicating that burglars in the UK have been known to steal unexpected items, like socks. This unusual behaviour is sometimes linked to quick grab-and-go crimes or thieves looking for easy-to-carry items. For instance, in some burglaries, particularly in areas with higher crime rates, personal belongings like socks or other small, easily concealed items may be taken either for resale or simply because they are quick to collect during a rushed break-in. While specific academic studies on this are scarce, broader burglary research consistently notes how offenders often target easily accessible or low-risk items, with some surprising choices in what gets stolen.
